Module 7: Instructor Guide

Module Overview

In this module, students will work independently on Moodle to learn the basic vocabulary, symbols, equipment, and documents surrounding the topic of Workplace Safety. This module will take students approximately five hours to complete all activities online. Students will work on this module while out of the classroom, before or during their 32-hour work attachment. This module has no official assessment tasks. Students will be assessed based on the results of quizzes throughout the module, and will receive either a complete or incomplete for each activity. While students are on their attachments, the instructor and instructor assistant will hold weekly office hours. During these hours, students can come to the computer lab and get assistance with the online modules, if necessary.

Module Objectives

- Increase knowledge of workplace safety through activities that use the nine Essential Skills. (All tasks and activities; Parts 1-4)
- Practise vocabulary building (Part 1 Activities 1, 2; Part 2 Activities 1, 2; Part 3 Activities 1, 2; Part 4- Activity 1)
- Practise using computers to learn (All tasks and activities are completed through Moodle.)

Students will look at the pictures then complete the activity that follows. This is a complete/incomplete activity.

Activity 6: How to Stay Safe – Writing Advice (Complete/Incomplete – manual grading)

Students will look at the pictures then complete the activity. This is a complete/incomplete activity.

Part 2: Safety Symbols

In Part 2 students will study safety symbols commonly found in workplaces in Alberta.

Activity 1: Vocabulary and Symbol Practice (Free Practice)

- Students practise the vocabulary for this module on their own time. They will complete a vocabulary quiz on Moodle when they feel they are ready. Students can attempt the quiz three times.

Activity 2: WHMIS Safety Symbols Quiz (Graded)

When students feel ready, they will complete the symbols quiz. They have three attempts and then the grade is recorded out of 10 marks.

Activity 3: WHMIS Symbols - Reading (Graded)

Students will read a document and look at the pictures, then they will complete the activity that follows. This is a complete/incomplete activity.

Activity 4: Identify the WHMIS Symbols on the Label (Graded)

Students will look at the pictures, then they will complete the activity that follows. This is a complete/incomplete activity.

Part 3: Safety Equipment

In Part 3, students will learn about common safety equipment used in workplaces throughout Alberta.

Activity 1: Vocabulary and Symbol Practice (Free Practice)

- Students click on Part 3 Module 7: Safety Symbols Quizlet at https://quizlet.com/_3lhr32
- 2. Students practise the vocabulary for this module on their own time. They will complete a vocabulary quiz on Moodle when they feel they are ready. Students can attempt the quiz three times.

Activity 2: Safety Equipment Quiz (Graded)

When students feel ready, they will complete the Safety Equipment Quiz. They have three attempts, then a grade is recorded out of 10 marks.

Activity 3: Personal Protective Equipment – Reading (Complete/Incomplete – manual grading)

Students will read a document, then they will complete the activity that follows. This is a complete/incomplete activity.

Activity 4: Identify the Correct PPE for Each Body Part

Activity 4A: Parts of the Body Vocabulary Review (Free Practice)

Students will use the Learning Chocolate links to review the parts of the body.

Activity 4B: Identify the Personal Protective Equipment (Graded)

Students will listen to each recording two times and then answer the corresponding multiple-choice questions.

Activity 5: (Graded)

Students will listen to each recording two times, then identify the corresponding safety equipment for each body part.

Part 4: Incident Report

Part 4 of Module 7 is only for CLB 4 and 5 students. It should be attempted by CLB 4, and definitely completed by CLB 5. Part 4 will introduce students to incident reports at the workplace.

Activity 1: Vocabulary (Free Practice)

- Students click on Module 7: Reporting an Incident at Work Quizlet at https://quizlet.com/ 3lzx2y
- 2. Students practise the vocabulary for Part 4 of Module 7 before they begin Activity 2. There is no quiz for this vocabulary list.

Activity 2: Incident at Work – Reading (Complete/Incomplete – manual grading)

Students will read a document and watch a video, then they will complete the activity that follows. This is a complete/incomplete activity.

Activity 3: Reporting an Incident at Work – Listening (Complete/Incomplete – manual grading)

Students will watch a YouTube video, then they will complete the activity that follows. This is a complete/incomplete activity.

Activity 4: Grammar – Past Continuous (Complete/Incomplete and Free Practice)

In this activity, students will learn about and practise the past continuous tense. They will need this grammar point to complete a detailed incident report. Students will read the grammar explanation and examples and then practise on Agenda Web. This may be difficult for some students. This would be a good opportunity to add more practice links to Moodle or to hold a brief grammar lesson during instructor office hours.

Activity 5: Fill Out the Incident Report (Manual grading)

Students will watch a video, then they will complete the incident report that follows. There are two separate incident report documents – one for CLB 4 and one for CLB 5. This is a complete/incomplete activity.

Description

Injury that occurred:

He hurt his back and neck.

Location:

At the construction site. On the second floor.

What was the person doing at the time of accident?

Paul was climbing the ladder when he fell off. He was carrying a pail.

What caused the injury?

He didn't hold on to the ladder with both hands. Also, he was not wearing a safety harness.

Describe in detail what happened?

Paul was climbing the ladder on the second floor when he fell. He walked up two steps then I saw him slip and fell off the ladder. He fell on to the ground. He fell very far. He hurt his back and neck very badly.

Activity 6: Safety Advice (Complete/Incomplete – manual grading)

This task is for CLB 5 students only. They will watch a **full** video and then record their responses to the questions. Although this video is out of Manitoba, most of the rules also apply to Alberta.

1. Describe in detail what happened to Clara.

Clara volunteered to do a job to cover another employee. She did not have training to run that machine. She told her employer and co-worker that she knew how to use the machine. She didn't know how to use the machine and couldn't find the foot pedal. She was using the machine when she cut her fingers.

2. What did Clara do wrong?

Clara didn't tell her employer that she didn't know how to use the machine. Clara ignored Nisha's warning.

3. What was Clara afraid of? Why was she afraid?

Clara was afraid she would lose her job.

4. What did Nisha do wrong?

Nisha didn't tell the employer when she noticed that Clara did not know how to use the machine. Nisha didn't stop Clara from using the machine without proper training.

5. What should Clara do differently next time to prevent another injury?

Clara should not do a job if she doesn't know how to do it. She should always ask for proper training.

6. What should Nisha do differently next time to prevent another injury?

Nisha should tell her employer immediately when she sees a co-worker working unsafely.

7. What should the supervisor do differently next time to prevent another injury?

The supervisor should not give a job to an employee who is not trained to do the job. He/she should make sure all employees have proper safety training. Also, the supervisor should make sure all machines have the proper safety devices on them before employees use them.

Final Reflection (Complete/Incomplete - manual marking)

Have **all** students complete the reflection at the end of Module 7. This is to show what they learned from the module.
